An application is hereby made to permit the placement of a waste or refuse container, commonly known as a roll-off dumpster or a roll-off container, on or along the above listed roadway location.

### Code of the Township of Nutley , Chapter 212 Streets and Sidewalks

#### Article II Obstructions, Encumbrances and Nuisances

**Section 212-4: Permission required to encumber streets and sidewalks.** No person or corporation shall encumber or obstruct, in whole or in part, any road, street, sidewalk or public place in the Town of Nutley with any article or thing whatsoever without first having obtained permission thereof from the Department of Public Safety.

**Section 212-5: Delay in removing encumbrances after notice.** Each day=s delay in removing any encumbrance or obstruction after having been notified by the Department of Public Safety to remove same shall be deemed a separate and additional violation of this Article.

#### Article III Guarding and Illuminating Excavations and Obstructions

**Section 212-7: Barricades Required.** Any person or corporation making or causing to be made any excavation or any obstruction of any kind whatsoever in, on or about any sidewalk, street or public place within the Township of Nutley shall keep such excavation and obstruction properly guarded at all times by barricades in such a manner that the safety of the public will be amply protected.

**Section 212-8: Illumination at nighttime required.** Any person or corporation making or causing to be made any excavation or any obstruction of any kind whatsoever in, on or about any sidewalk, street or public place within the Township of Nutley shall keep such excavation or obstruction properly illuminated between the hours of sunset and sunrise in such a manner that the safety of the public will be amply protected.

**Section 212-10: Violations and penalties.** Any person or corporation violating any provision of this Article shall, upon conviction thereof, be liable to a penalty of a fine not to exceed five hundred dollars (\$500.) or be confined in the county jail for a term not exceeding ninety (90) days, or both.

If approved, this permit shall be valid for a period of 7 days and may be renewed by this approving authority.
