## REQUIREMENTS

- No permit is required for dumpsters and/or construction trailers employed in the construction of a new residence or for use of a storage trailer, PODS or similar device for a period of four (4) days or less **provided prior notice has been given to the City Engineer, 636-227-1385, x109.**
- Work shall occur between 7:00 a.m. and 3:30 p.m. with all roadways opened for traffic at all times. Permit holder shall provide an adequate driving surface on and along all roadways as necessary. **The City's Public Works Department shall be notified twenty-four (24) hours in advance of the work, call 636-227-1385, x104.**
- The Contractor shall provide and maintain traffic control measures at all times.
- All barricades/barrels shall have lights in working condition and reflective tape and proper work signage shall be placed appropriately.
- Complete the work in the agreed to time frame and restore all disturbed areas to their original condition.
- Contractor shall follow applicable articles of the "St. Louis County Standard Specifications for Highway Construction." Failure to provide proper traffic control or to protect the streets from possible damage will result in the City taking whatever action is necessary to restore disrupted areas and the immediate revocation of this permit as well as undertaking legal action to recover expended public funds above the submitted amount.
